## **GETTING STARTED**



You must submit an Expression of Interest (EOI) through the Australian Government's SkillSelect to be invited to apply for any subclass of the General Visa.

#### Submitting your EOI:

- Check that your occupation is on the List of Eligible Skilled Occupations for the Skilled Independent Visa (subclass 189).
- You must have a suitable Skills Assessment which is undertaken by an assessing authority listed against your occupation.
- You must be able to obtain at least 65 points on the Australian Government's Points Test to be eligible.



We advise that you familiarise yourself with the following Checklist to ensure you have all the required documents/evidence ready to go.

### Once you receive your invitation to apply, the following documents are required for your visa application:

- Identity documents
- Relationship documents
- Character documents
- Proof you have at least "competent English" at the time of application.
- O Partner documents for evidence of their identity and relationship with you.
- Proof your partner has "functional English" unless they are a citizen of a country on the exemption list.
- Oldentity documents for dependants under 18 who are applying with you.
- Ensure any child over 18 in your visa application meets the eligible criteria and provide proof.
- Skills Assessment documents that support the claims made in your EOI.
- Using the Points Table, provide Expression of Interest (EOI) documents to support all claims made in your EOI.
